PROPER PLANNING CAN HELP EASE YOUR MIND

Having an estate plan in place can bring peace of mind in an everchanging world.

Once established, your plans should be reviewed regularly to be sure they keep up with the changes in your life.

For example, the birth of a child, a change in marital status, or a career change that brings substantially greater earnings are the types of life events that can call for a review of your will and other plans.

UMCOR-supported water and sanitation projects in a dozen countries are helping thousands of people access safe water to meet their day-to-day needs.

Over the last decade that UMCOR has been involved in the Democratic Republic of Congo, improved water supplies and sanitation have been achieved for thousands of Congolese. Donor support has allowed UMCOR to deliver hygiene education as well as dig new wells, provide improved water carrying and storage capacity, and construct latrines in many places.

A Legacy of Service

Martha (Marty) McKnight learned the importance and joy of serving others early in life. She was born to Methodist missionary parents who were serving in Angola, then a Portuguese colony on the western coast of Africa. As a child, Marty witnessed her parents sharing the love of Christ as they provided medical care and educational ministry. People came from near and far to the Quessua hospital and boarding schools where her parents served.

As an adult, Marty was led to pursue missionary service with her husband, Ted. They served in Johannesburg, South Africa, where they met regularly with men from

Mozambique who came to work in the gold and coal mines. Through the McKnights' efforts, the people they met with learned to read and write, studied the Bible and learned about church membership, as well as agriculture and hygiene. Though the McKnights have long since returned to the United States, their legacy of service is continued through financial giving to provide health care, literacy, and pastoral support that enhances life and continues to bring hope in Africa today.

Creating Your Legacy

A gift through your will or other estate plan lets you continue your support of Global Ministries and the United Methodist Committee on Relief (UMCOR) into the future.

A properly planned legacy gift offers potential tax and other financial benefits for your estate and/or heirs. It is important that you consider how such charitable gifts might impact your overall estate plan, so always consult your lawyer and other professional advisors when determining your legacy gift.

- Make a bequest in your will or other estate plan.
 When you make or update a will, you may include charitable bequests of a specific dollar amount, a percentage of what is left after other bequests have been made, or even a particular asset. You may be able to add a bequest to an existing will through a codicil or amendment.
- Make Global Ministries and/or UMCOR the beneficiary of a retirement plan. When you leave the balance of

an IRA or 401(k) to your heirs, they must carefully manage the account to avoid losing its tax-deferred status and potentially triggering large income taxes and possible penalties. You can simplify matters for your loved ones by directing all or a portion of what remains in your retirement accounts to charities and leaving other more tax-favored assets to your heirs.

Designating a charitable beneficiary of an IRA or 401(k) does not require you to change your will. It is important to check with your plan manager to make sure your current intent is reflected on your beneficiary designation.

Turn unneeded life insurance into a gift to Global
Ministries and/or UMCOR. You can also make Global
Ministries and/or UMCOR the beneficiary of life
insurance policies without changing your will. As
your financial and family circumstances change
over the years, you may have life insurance policies
